Preamble:

In order to protect the welfare of transgender persons in the state and to protect their rights at the state level and at the divisional level, to establish transgender rights in the state and to establish a welfare board. Approved by Government Resolution dated 13th December 2018. The structure, functions and objectives of the Board have been defined by this Government Decision. Accordingly, the issue of protection of Maharashtra State Transgender Rights and appointment of members to the Welfare Board was under consideration of the Government.

Government Decision-

For the purpose of protecting the welfare of transgender persons in the State and their rights, at the state level and at the divisional level for the protection of transgender persons' rights and the establishment of a welfare board. Approved by Government Resolution dated 13th December 2018. As per the structure of the Board as decided by this Government Decision, the following members are to be appointed on the Protection of Transgenders Rights and Welfare Board at the State level.
